Currently a senior partner in the South Carolina law firm of Nelson Mullins Riley & Scarborough, L.L.P, with offices also in North Carolina, Georgia and Washington, D.C., he counsels clients and works with partners to develop strategy on complex business, governance, financial and legal matters for local, national and international clients. Secretary Riley earned his bachelor's degree, cum laude, in political science from Furman in 1954 and received a J.D. from the University of South Carolina School of Law in 1959. He is the recipient of numerous education and other public service awards, as well as honorary degrees from universities and colleges in the United States and abroad.

Jo Anne Anderson serves as executive director of the South Carolina Education Oversight Committee. The Committee bears responsibilities for the development and ongoing improvement of South Carolina's educational accountability system.
